ADVISORY FOR CORDILLERA DAY 2009

TO ALL DELEGATES AND FRIENDS,

Greetings from CPA! As mentioned in the Cordillera Day 2009 invitation sent earlier, this advisory is issued for your guidance.

- A. Cordillera Day 2009 on April 23-24, 2009
- 1. Cordillera Day 2009 is the the 25th Cordillera Day Celebration
- 2. Decentralized celebration under a Central Theme

As in the Cordillera Day 1995 celebration, this year's Cordillera Day will be a decentralized celebration which means one province or two adjacent provinces holding a separate, though simultaneous, commemorative activity on the said dates. As a decentralized Cordillera Day, each province and chapter will define the specific nature of its own celebration based on the urgent issues and concerns of the province. It serves as an event to further strengthen the unity and struggles of the communities to be able to confront the crisis and challenges they face.

The central theme "Strengthen people's solidarity. Intensify the struggle for land, life, and rights!" will guide the decentralized celebrations. The central theme carries key issues and concerns for this year's celebration on the following: continuing plunder of our ancestral land resources like big corporate and transnational mining; worsening human rights violations due to militarization, extrajudicial killings, enforced disappearance, and political repression; violation of our people's basic rights to livelihood and welfare; impending charter change; and the global economic crisis and impact to our people. It is expected that each celebration will come up with resolutions and action plans on how to address these burning issues under the central theme.

B. Activities in celebration of decentralized Cordillera Day 2009

5. Ifugao

April 19: Gathering of the Friends of James Balao to coincide with his birthday. James Balao is a

founding member of CPA, also worked in Ifugao with invaluable contribution for the rights and welfare of the Ifugao and Cordillera peoples. He was abducted by State armed forces in

September 17, 2008 and remains missing until now.

Discussion on Food Security and Environmental Protection

April 22-24: Participation to municipal festivals with the local governments

Local issues: human rights and enforced disappearance of James Balao, food security, environmental

protection

Final and detailed programme for each celebration will follow soon.

- **C. Provinces open for national and international delegates.** Considering the specific nature and activity per celebration, facilitation and translation, the following provinces and cluster celebrations are open for national and international delegates at this time:
 - 1. Baguio-Benguet in Bakun
 - 2. Mountain Province in Sagada.
 - 3. Kalinga-Apayao in Tabuk

Announcement in case of additional provinces will follow. National and international delegates can suggest where to attend based on the issues and concerns appropriate to their particular interest and objective in attending Cordillera Day. Provinces capable of hosting national and international delegates must constitute a facilitation and translation committee for these delegates.

C. Confirmation of Participation. Last day of confirmation of participation including the number of delegation to Cordillera Day 2008 is April 15. Also, distribution of national and international delegates will be final on this day so all are encouraged to confirm their participation earlier than April 15 including their suggestion where to go.

D. Travel and Coordination for national and international delegates

1. The center of coordination on travel arrangements for all international, national and other delegates coming and passing through Manila is assigned to our organization in Manila, Tignayan dagiti Agtutubo iti Kordilyera para ti Demokrasya ken Rang-ay (TAKDER, or Cordillera Youth Movement for Democracy and Progress). Kindly coordinate directly with TAKDER and look for Mr. Richard Gadit with the following contact details:

TAKDER will call for a briefing of national delegates. The safe travel budget for each national delegate will be determined as soon as the celebration to attend is identified. TAKDER will issue an advisory on travel arrangements and budget.

International delegates must determine their own travel and related expenses from their home countries to Manila and vice versa.

- 2. Each delegation is also reminded to constitute and prepare a negotiating panel in case of military and police checkpoints or similar incidents during travel. Delegates must bring their IDs, cedula or any legal identification.
- **E. Registration Fee and Donations**. As mentioned in the invitation letter, we will be collecting a registration fee of PhP300 to help cover food expenses. We are also soliciting financial contributions and donations to help us defray expenses on logistics, food, and travel assistance for grassroots organizations and indigenous communities comprising the majority of expected participants.

F. Things to Bring

In addition to the abovementioned, delegates are encouraged to bring the following:

- 1. Indigenous attires and musical instruments
- 2. Bandana, scarf or hat
- 3. Mineral water and food during travel to the venue
- 4. Flashlight with batteries and extra bulb
- 5. Light clothes (summer wear), light jackets, and hiking shoes or sandals
- 6. Emergency food or food supplements especially for vegetarians
- 7. Organizational banners and streamers
- 8. Personal medicines
